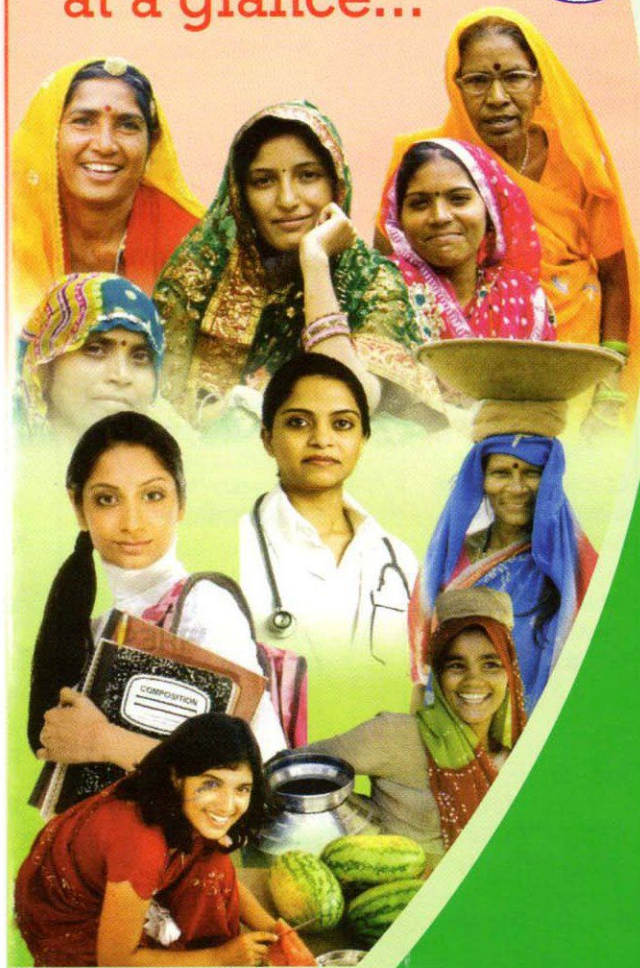

## Women related law at a glance...

| Offence   | I.P.C. | Punishment  |

| • In a public place obscene acts and songs  | 294    | 3 Months / fine or both   |
| • Dowry Death   | 304 B  | Lifetime Imprisonment but not less than Seven years   |
| • Abetment of Suicide   | 306    | Ten years imprisonment & fine   |
| • Causing Miscarriage   | 312    | Three years or fine or both Seven years and fine  |
| • Causing Miscarriage without women's consent   | 313    | Ten years to lifetime imprisonment + fine   |
| • Voluntarily causing grievous hurt by use of acid etc.   | 326    | Ten years imprisonment which shall be extend to lifetime imprisonment and fine  |
| • Assault or use of criminal force to woman intent to outrage her modesty   | 354    | minimum 1 year which extend more to 5 years and fine  |
| • Sexual harassment, and<br>1. Unwelcome Physical contact and advances<br>2. Or a demand or request for sexual favours<br>3. Showing pornography literature against women's will or | 354 A  | Imprisonment for 3 years or fine or both for subclause 1,2,3 and for sub section 4 imprisonment upto "One year" or fine or with both. |

| • Under photography to see private part of women including taking pictures and spreading                  | 354 C  | On first time convicted minimum 1 year imprisonment which extend to 3 years and fine but after that minimum 3 years imprisonment which extend to 7 years and fine |
| • Stalking in which using of monitoring by Internet / email or any kinds of electronic resources included | 354 D  | On first time convicted 3 year imprisonment and after that 5 year imprisonment and fine   |
| • Taking or enticing away a minor girl out of the keeping without knowledge of a lawful guardian          | 363    | 7 years + fine  |
| • Kidnaping, abducting or inducing a women to compel her marriage   | 366    | 10 years + fine   |
| • A minor girl is procurement   | 366A   | Ten years imprisonment and fine   |
| • Importation of girls for foreign country  | 366 B  | Ten years imprisonment & fine   |

| ● Rape  | 376         | Minimum 7 year imprisonment which extend to lifetime or 10 years and fine     |
| ● Death of victim or committing continuously vegetative state   | 376 A       | 20 years imprisonment which extend to lifetime imprisonment or death sentence |
| ● Sexual intercourse by husband upon his wife during separation   | 376 B       | Minimum 2 year which extend to 7 years and fine                               |
| ● Sexual intercourse by any person in authority   | 376 C       | Minimum 5 year which extend to 10 years and fine                              |
| ● Gang Rape   | 376 D       | Minimum 20 year imprisonment which extend to lifetime imprisonment and fine   |
| ● For repeatedly offenders  | 376 E       | Lifetime Imprisonment or Death Sentence                                       |
| ● Unnatural offences  | 377         | 10 years imprisonment and fine  |
| ● A man by deceit causing a woman not lawfully married to him to believe that she is lawfully married to him and to | 493         | 10 years imprisonment and fine  |

### In the provision of Dowry Prohibition Act

| Offence                   | I.P.C. | Punishment                                   |
|---------------------------|--------|--|
| • Dowry Received or given | 3      | 5 years + fine                               |
| • Dowry                   | 4      | Minimum 6 months<br>Maximum 2 years and fine |



## Women related law at a glance...

### In the provision of Code of Criminal Procedure

| Offence   | I.P.C. |
|---|--------|
| • No woman shall be arrested after sunset and before sunrise and where such exceptional circumstances exist through woman police officer obtain the prior permission of the Judicial Magistrate | 46     |
| • Maintenance   | 125    |
| • No any women shall be required to attend at any place other than the place in which such woman resides  | 160    |
| • The inquiry and trial of rape shall be conducted in close room  | 327    |

### Other Important Facts

- Protection of Women from Domestic Violence Act 2005 came into force for Right's of Women.
- In case of Vishakha v/s State of Rajasthan, the direction of Supreme Court regarding Sexual harassment of women at workplace. (Ref. : 1997 Supreme Court Cases (Criminal) 932).
- According to section-6 of Hindu Succession Act Right who had right for male decedents, the same will have for Women (Daughter) decedents successors.
